Ten \$50,000 grants will be awarded to advance curriculum, update technology for 21st-century learning environments, and increase student exposure to STEM education.

Funds are available to address needs in technology or resources (i.e. software, equipment, books, training of teachers, tutors, paraprofessionals) to advance the STEM curriculum and increase exposure of STEM education and careers to students.

Applicant Criteria:

» This grant is open to all K-12 public schools and eligible private and charter schools within FPL's service area in Florida that are designated as Title 1 or serve a student population with at least 40% economically disadvantaged students.

The Classroom Makeover Grant Program is a gift by the NextEra Energy Foundation, a corporate foundation of NextEra Energy, Inc. and Florida Power & Light Company.

Up to ten schools will be selected to each receive the \$50,000 grant.

Public, private or charter schools

FREQUENTLY ASKED QUESTIONS (FAQS)

1. How will I be contacted or know if I received a grant?

If you are awarded a grant, your principal and local education foundation will be notified in early 2026 via the email address provided in your grant application. Grant applicants not awarded will also receive notification via email.

2. Can I change my application after it's been submitted?

Unfortunately, your application cannot be changed once it is submitted, so please review it carefully. Applications are due Friday, Nov. 7, 2025, 11:59 p.m. EST

3. If I apply this year, does that hinder my ability to apply in future years?

No. Teachers/school administrators can apply each year the grant is offered.

4. What can the grant be used for? Do I get to decide what improvements are made?

This grant is intended to provide transformational learning opportunities in a classroom setting. Funds are available to address needs in technology and resources that advance the STEM curriculum and increase student exposure to STEM education and careers. Resources may include software, 3D printers, hydroponics, virtual reality, incubators, labs, aviation, robotics and interactive displays. Yes — you decide what improvements are made if you are awarded.

6. Can more than one teacher from the same school apply?

Yes. Teachers/administrators from public, private and charter schools at all grade levels are encouraged to apply. Applicants must be a Title 1 school or from schools that serve a minimum of 40% of economically disadvantaged students, provide a budget, and submit a letter from the school principal supporting the application.

7. What if I'm not able to submit the application online or need help?

8. May I submit the application late?

All applications are due no later than Friday, Nov. 7, 2025, 11:59 p.m. EST

9. What if my school is experiencing financial and other challenges during the grant period and may be impacted?

If your school is awarded, you will collaborate with your education foundation (fiduciary agent) to discuss implementation and determine next steps.

10. Will I have to manage the budget and transformational process by myself?

Yes, but your local education foundation will serve as the fiduciary agent and guide you through the entire makeover process.
