\$50 RESTAURANT.COM ONLINE CODE PROMOTION

These Official Rules apply to the **FPL Automatic Bill Pay®** \$50 Restaurant.com online code Promotion (“Promotion”) being conducted by Florida Power & Light Company (“FPL”). This Promotion **begins on Mon., September 1, 2025** at 12:01 AM (ET) and **ends on Tues., October 7, 2025**, at 11:59 PM (ET) (the “Promotion Period”). The clock on FPL’s website will be the official timekeeper for this Promotion. THIS ONLINE CODE PROMOTION IS VOID WHERE PROHIBITED BY LAW OR REGULATORY ORDER BY THE FLORIDA PUBLIC SERVICE COMMISSION.

Eligibility:

THIS PROMOTION IS NOT OPEN TO THE GENERAL PUBLIC. DO NOT PROCEED IN THIS PROMOTION IF YOU ARE NOT AN FPL CUSTOMER WHO IS ELIGIBLE PURSUANT TO THESE OFFICIAL RULES.
