



FPL ON CALL® \$100 RESTAURANT.COM CODE PROMOTION

OFFICIAL RULES

These Official Rules apply to the FPL **On Call**® \$100 Restaurant.com Code Promotion ("Promotion") being conducted by Florida Power & Light Company ("FPL"). This Promotion **begins on Monday, October 6, 2025**, at 12:01 AM (ET) and **ends on Sunday, November 30, 2025**, at 11:59 PM (ET) (the "Promotion Period"). The clock on FPL's website will be the official timekeeper for this Promotion. THIS CODE PROMOTION IS VOID WHERE PROHIBITED BY LAW OR REGULATORY ORDER BY THE FLORIDA PUBLIC SERVICE COMMISSION.

Eligibility:

THIS PROMOTION IS NOT OPEN TO THE GENERAL PUBLIC. DO NOT PROCEED IN THIS PROMOTION IF YOU ARE NOT AN FPL CUSTOMER WHO IS ELIGIBLE PURSUANT TO THESE OFFICIAL RULES. This Promotion is open only to FPL's customers as of **Monday, October 6, 2025**, who are 18 years of age or older at the time of entry and legal residents of Florida, with a valid email on their FPL Account, and who have received an email or digital advertising from FPL requesting their participation in the Promotion.
